Minutes of the Annual Congregational Meeting The Good Shepherd United Church of Christ March 10, 2024

Reverend Randy Mayer offered an opening prayer. Kathy Babcock, Moderator, called the meeting to order, and a quorum of 79 people was established. The minutes of the 2023 annual meeting were unanimously approved.

Reverend Mayer, Senior Pastor, while referring the congregation to his written report, highlighted the following events of the past year: the staff, thanking Rebecca McElfresh, Alejandra Rosas, and Keenan Dolan and welcoming new staff members, Rev. ellie hutchison, Margaret Kofron, and Mengda Jiang; the follow-up actions after the February SOAR Conference; the changes in the congregation due to deaths, moves, and new members; the establishment of the Family Resource Center with the SFB and the United Way; and he thanked the members of the Admin Team and Office Manager, Amy Dillemuth.

Reverend ellie hutchison, Pastor of Pastoral Care and Spiritual Growth, thanked Rebecca McElfresh for her impact and influence in ellie's accepting the position. They noted Rebecca's creative approach to and efforts in fostering spiritual growth. They also recognized Margaret Kofron's support in faith formation and spiritual growth.

Rick Irvin gave the treasurer's report, emphasizing the excellent financial shape of the church. He presented the Finance Team's proposed 2024 "faith-based" budget for approval. Rich Hill moved "to accept the 2024 budget as presented at this annual meeting and to approve spending at this level until the 2025 budget is approved at the 2025 annual meeting." John Merrill seconded the motion. The motion passed. Rick announced that TGS accounts were being moved from Wells Fargo to US Bank. He thanked the congregation for its generosity, having not only met the commitments of the 2023 budget but also having donated \$28,000 in "pass through" money for various fund drives. In addition, he thanked Amy Dillemuth for her excellent support in helping him manage the church finances.

Kathy Babcock asked for a motion to accept the annual church written reports from the various teams. Dennis St. John moved, and Doug Syme seconded the motion. The motion passed.

Hathaway Cornelius, Chair of the Nominating Committee, presented the slate of officers and team members; and he thanked them for their willingness to serve. Doug Syme and Rick Irvin moved and seconded that the slate be accepted. The motion carried. Kathy thanked Hathaway for his work on creating the slate.

In New Business, Mike Day reported for the Environmental Justice Group, which developed after the SOAR Conference. He noted three projects the group is pursuing: a) the copper recycling, b) a charging station and c) a climate emergency service center. The first is operating, the second is tabled and the third is in the research and planning stage. Mike invited people interested in helping research and develop a plan for such a center over the next 6 months to join the Group.

Kathy Babcock thanked the Admin Team and the Sub team members and clergy for their work and support of the past year. She then introduced the new moderator and moderator elect, Doug Syme and Linda Sielken. Doug presented Kathy with a thank you gift and flowers. He then thanked the congregation for their confidence in him and invited people to come to him with questions and concerns they might have about the church and its administration.

The closing prayer was offered by ellie hutchison. Doug Syme closed the meeting at 5:40 p.m.

Report of the Moderator, Doug Syme

I was asked recently to describe the role of Moderator. My response was, "Challenging but fulfilling". I can say that being your Moderator for the past year has been fulfilling in many ways but not without many challenges. The Good Shepherd United Church of Christ consists of a great number of Ministries, Missions and Programs which, to the casual observer, appear to operate like clockwork. Over the past two years as Moderator-elect and Moderator, I have learned of many elements that keep the clock ticking, but I confess that I am still learning. We are blessed that we have a dedicated staff but, even more so, that we have so many volunteers that serve us in matters great and small to create the organized image we present. I thank everyone who contributes time and talent in so many ways,

I will be eternally grateful for the support I have received. I hesitate to list all those who have done so as I would surely miss many. But I must thank Amy Dillemuth for her patience, kindness, and unending willingness to share her institutional knowledge of how our church operates. It is no secret that Amy has decided that nearly two decades of service to The Good Shepherd has brought her to a point of wishing to pursue other goals. She will leave us in the summer. I can only say that whoever sits in the corner office in the future will have a challenge in front of them. As is Amy's nature, she has prepared manuals, instructions, etc. to make the challenge more manageable.

One of the elements in planning for Amy's departure is that we have engaged an outside firm, Focus/HR, to take care of payroll, associated tax matters and provide professional personnel advice. This change is presently being implemented and will be operational, we hope, in March.

As noted above, so many tasks that we take for granted are carried out with hardly any notice, but one project carried out in the fall deserves mention. A subcommittee of the Finance Team reviewed two months of financial transactions to ensure that all was in order and above board. While no serious irregularities were found, the review discovered that we were overlooking some practices adopted by the Administration Team a decade ago – principally the need for independent professional review of our accounts on a regular basis. The Finance team has appointed a subcommittee to evaluate and implement the recommendations of the Financial Review report and this subcommittee's deliberations are expected to conclude soon.

Another project worth noting is a review of our By-laws. We had made good progress by last summer when my eyes began to fail me. I am determined to help your incoming Moderator complete the task.

In conclusion, again I thank you all for keeping the Ministries, Missions, and Programs of The Good Shepherd moving forward and I thank you for making my service as Moderator so fulfilling

Report of the Senior Minister, Rev. Dr. Randy Mayer

The Good Shepherd is an active, dynamic faith community that engages its members, friends and wider community. Each year it is good to step back and take a look at all that has happened over the year and be inspired and in awe.

At the very center of our church are its worship services. Our 9:00am service is still our bread and butter with our great choir and a strong tradition of meaningful worship. The 11:15am service is geared toward families and contemporary music with a band. The Taizé service held once a month on Thursday evenings is a beautiful contemplative service. Leadership of the Taizé service changed this year and is now in the capable hands of Ted Virts. Our hope is that whatever service people attend, they leave inspired to go out into the community and do good works and share the values of love and inclusion

Caring for our congregation is another key area of our church. The Care Committee has reorganized but continues to care for the sick, visits shut-ins, offer grief groups and other support groups. As a congregation we continue to care for people that are hurting or excluded. The Good Shepherd is a safe space that offers healing and wholeness so people can find their way once again.

Over the years The Good Shepherd has created important programs that have helped form our church's identity and have a massive impact on the wider community. The Estate Sales continue its service to the community. The Sahuarita Food Bank and Community Resource Center that sits on our property continues to grow and expand its services. The Spanish Program continues to teach the Spanish Language to 30 or more folks each year. In late March a group of nearly 20 people will head to Antigua, Guatemala to study and maintain our relationship with Probigua, a language school and scholarship program in Guatemala. The GV/Sahuarita Samaritans continues to be an important border humanitarian group especially in these times when so much national attention is focused on the border. Common Ground on the Border continues to be a transformative event that attract 200+ people from around the country. The Studio has reorganized its leadership and is offering an amazing array of art classes. The Javarita Coffeehouse continues to offer magnificent acoustic roots concerts. And La Casa de la Misericordia, a migrant shelter in Nogales, Mexico continues to be a central project of the Good Shepherd.

Our facilities are well used. The Family Resource Center of the United Way/Sahuarita Food Bank continues to rent two of our classrooms for their children's programs. It is great to see the young children and their parents on our campus. Dennis St John has done an incredible job with our three Scouting for America troops and the Cub Scout Pack. On Monday evenings every nook and cranny at the Good Shepherd is filled with scouts. We continue to be the meeting place for the Community Justice Board, two Al-Anon and two Alcoholics Anonymous groups. Groups that meet at the Good Shepherd find our space welcoming and flexible,

Finally, I want to say how honored I am to be your pastor. The Good Shepherd has developed into quite a church, thanks to so many people who give without hesitation their time, skills and energy. Special thanks to Treasurer Rick Irvin who has skillfully guided the Good Shepherd's finances over the past 7 years and will be stepping down in March. We are grateful for Moderator Doug Syme, Vice Moderator Linda Seiken, Secretary Carrie DeProspero who have all served with distinction. Kathy Babcock has done an incredible job reorganizing and staffing our personnel committee. And a special Thank You goes to Leslie DeGrassi who has created and guided our web site over the last 10 years and is stepping down from that role.

And of course, a heartfelt gratitude to the Good Shepherd Staff—ellie hutchison, Amy Dillemuth, Mengda Jiang, Rada O'Neal, Larry Worster, Severo Rivas, Eva Cruz, Thomas Dillemuth and Carson Hawks. Without the skill and commitment of these hard workers the Good Shepherd would not be able to function.

Report of the Minister of Pastoral Care and Spiritual Growth – Rev. ellie hutchison

In 2024, i began the year observing and learning what was cultivated prior to my arrival. While there was some grief with the loss of the former Associate Pastor, i found there was much excitement about reintroducing or dreaming anew the ways in which Care and Spiritual Development is done within the church.

One thing became evident after speaking with leadership, was the desire for the congregations' "ownership" of certain aspects for sustainability as well as to help fill the gaps of when pastoral staff might not be available. This also became evident when i was asked to start a new grief group but found out that there was actually a current group that became insular, not allowing newly widowed individuals to participate. While i don't know why this was the case or how it became so, i invited and encouraged that group to open up and welcome all who have recently lost someone which they now do. i also started a ZOOM meeting through my account with the Church that allowed this group to meet without having to reconnect after 40-minutes as they were on a free account and had to reconnect after the 40-minutes expired.

In hearing from congregation members, it became evident that there was a need for a Caring for the Caregiving program as it relates to Alzheimer's and Dementia and after researching a number of existing programs throughout Pima County, i decided to work with DUET-AZ and asked congregation members to co-facilitate a group with me. This program will start in 2025 with co-facilitator, Liz Symington.

i started co-leading the CARE Team alongside Linda Redfield and we explored what was being done already and what was needed or missing. One thing that was mentioned was the need for a meal train for those who were housebound or had gone through a recent trauma or loss but after research, it was discovered that most Amigos Groups handle this when needed. We also continued the tradition that at Christmas and Easter, Care Team Members would fill out homemade cards and invite those in attendance at the services to deliver floral greetings to those who were sick or those who had lost a loved one during the year. In 2025, i know a number of CARE team members will be stepping aside due to wanting to explore other servant roles at the church or to step aside from this work in general and so we'll be reimagining what the CARE Team will be in 2025 and beyond. i've also visited with a number of congregation members in their homes or via electronic/virtual means and have administered Communion to those who are housebound.

This past year, i've preached monthly and continued the prison ministry (that of which i was hired knowing i participate in) monthly. i led a series on the Book of Revelation in Summer 2024 and hope to lead a Summer 2025 series on the Book of Acts. And have conducted three studies including the Sanctified Arts Lenten study, AJ Jacob's "A Year of Living Biblically", and Robin Wall Kimmerer's "Braiding Sweetgrass".

Overall, it has been a magnificent year of learning and growing alongside the congregation and i'm excited for what 2025 holds for all of us.

Report of the Music Director, Mengda Jiang

This year, our choir organized special music programs for major church celebrations, including an Easter Requiem in Chinese and a Christmas Cantata. We also provided music leadership for weekly services, aiming to incorporate a broader range of musical styles. To strengthen the choir and broaden our repertoire, we engaged two wonderful singers: Betsy and Erica who brought additional skill and depth to our performances. Working closely with our clarinet player, John, and our pianist, Rada, we were able to enhance the overall sound and create an even more uplifting worship experience.

One of our ongoing projects has been the reorganization of the music library. My plan is to complete this task by March, ensuring that materials are better managed and easily accessible for future use. Looking ahead, we plan to introduce a wider variety of worship music, grow the choir, and potentially rebuild our handbell choir next year to further enrich our congregational life.

Report of the Contemporary Music Director, Larry Worster

Accomplishments 2024:

- Presenting a repertoire that meshes effectively with our theology
- Worked with the technical staff to create and maintain a system for the amplification and broadcast of the service.
- Creation of lyric sheets and charts for the band and the bulletin on a timely basis each week.
- Managed transitions in band personnel so that the congregation did not notice a change in quality.
- Increased the quality of performance with three musicians who have been regular participants over the last year, and a new female vocalist.
- Progress made in training the new sound engineer

Recommendations:

- I recommend that we move proactively on hiring a replacement for the audio engineer/technician.
- We will be losing a regular guitarist in the winter season, who is moving back to Minnesota. I have already started working on finding his replacement. Thank you to Lawrence Severt for three great years!

Worship and Music Committee

Music: During the Summer, the committee worked with the Church Personnel Committee in establishing job descriptions for all paid Church musicians.

Director of Music for the Traditional Service, Dr. Mengda Jiang, had an annual review which took place in October with members of the Personnel Committee and Worship and Music Committee participating. Rada Neal continued through the year as accompanist in the 9:00 am Traditional service, and we expressed our appreciation for her work at her annual review also held in October. Upon hearing word of the death in April of Rada's husband, the Committee worked quickly to find substitute musicians to fill in for her through the end of July.

A former long-time member of the choir expressed her thoughts about the mission of the choir in this way. "The members don't just show up, practice on Thursday and Sunday and produce an anthem, but they take positions within the leadership ranks of our Church and genuinely care about each other. They nurture where and when needed." Kudos to Choir members.

Larry Worster continued his fine leadership in recruiting band members and service music for the Contemporary service. It's not easy to find band musicians but Larry always seems to find them.

Altar Decoration: The many seasons of the church calendar provide opportunities for decoration of the altar. Rosemary Stoltenberg, Arlynne Ostlund and Ellen Cox continue to present artistically inspirational creations.

Report of the Office Administrator/Financial Secretary, Amy Dillemuth

In 2024, The Good Shepherd continued to be a vital and vibrant place of worship and fellowship. Services were held in person each week. The Spark Studio gave many opportunities for folks to gather and be creative. The Family Resource Center continued offering activities for families with young children. Many other church activities were offered: Spanish classes, the Patio Sale, Estate Sales, and book studies to name a few.

Here are highlights of some of what came through the office in 2024:

- Ordered and maintained supplies for the office, various teams, custodian and kitchen.
- Mailed and emailed contribution statements during the year. Emailing these documents makes this job quick and saves much money on postage: truly a gift!
- Worked with Rick Irvin on bookkeeping tasks and maintained files for the Treasurer including recording
 weekly collection and deposits, creating financial reports, paying bills, running payroll and taking care of
 employee taxes, helping create the budget, reconciling accounts and maintaining the financial database to
 track congregational contributions. This also includes maintaining the Samaritan, Men's Fellowship,
 Women's Fellowship, and Estate/Patio Sales group financial records. I also take care of the Memorial Gift
 incoming checks and acknowledgments to donors and families.
- Helped find and hire focus/HR (a Tucson company) to provide payroll and Human Resources support.
- Compiled weekly bulletin, email news, and prayers. We send two regular emails weekly. The email prayer
 (with prayer list) is sent on Wednesdays, and the newsletter, with the bulletin included, on Thursdays. If you
 wish to be added to either or both lists please let me know! Many thanks to Kay Kennard for taking time to
 edit publications for me. Kay catches my mistakes and helps provide quality finished documents for everyone.
- Supported Leslie DeGrassi with the church website.
- Provided Administrative support for Rev. Randy Mayer, Rev. ellie hutchison, Rick Irvin, and the teams and committees of The Good Shepherd as needed.
- Coordinated the calendar and facility for events and meetings, working with our custodian to ensure appropriate setup and access. Aided with opening rooms and setting them up as needed.
- Compiled 2023 Annual Report for The Good Shepherd and 2023 Southwest Conference Annual Report information.

I want to thank a few of the many, many people who help me so often: Rev. Randy Mayer, ellie hutchison, Severo Rivas, Eva Reyes Cruz, Rick Irvin, Kathy Babcock, and all the other volunteers who are always so generous with their time and talents.

2025 promises to be another wonderful, busy, and change-filled year at The Good Shepherd. In October of 2024, I completed my 18th year of employment here – my how time flies! Report of the Facilities Team

The Good Shepherd facility is largely maintained by a few dedicated employees and a core of selected contractors. Much of the day-to-day maintenance is coordinated by Amy Dillemuth or Randy Mayer. Angel Figueroa should be applauded for keeping our exterior landscape and irrigation systems in great shape and thanks to our Custodian, Severo Rivas, for keeping the facility in order while handling all the special furniture arrangements and special requests demanded by our ever-changing programs. And we all appreciate the cleanliness of our buildings and restrooms thanks to the constant help of Eva Reyes-Cruz and her family.

The Charman of the Facilities Team or his designee works with Amy Dillemuth in coordinating and monitoring various contract companies handling on a predictable schedule the routine maintenance or inspection requirements for the facility. Included are items such as the annual fire alarm testing, kitchen safety inspections, back flow (water) certifications, door repairs, and rekeying when required.

As a team, facilities personnel participated in special projects that involved refinishing the floor in the Redman Room, unpacking received furniture, cleaning out storage areas, and re-lamping many lighting fixtures as energy efficient LED units. Thanks for your participation.

Report of the Finance Team

The Finance Team reviewed monthly the church income and expenses, and the balance sheet, tracking them with the budget. All funds were managed to maximize our stewardship opportunities. Our thanks are extended to everyone who contributed generously to the positive financial year in 2024. Your generosity and support of The Good Shepherd is greatly appreciated.

Actions were implemented and completed to change our banking relationship to US Bank to improve service and returns.

A proposal to engage a payroll processing company to provide services to The Good Shepherd was evaluated. Four proposals were reviewed and the selection of FOCUS HR, who will provide payroll and tax processing as well as professional HR assistance, was recommended to the Administrative Team.

Teller recruitment throughout the year resulted in six new volunteers to assist in the weekly tabulation of church receipts. The team extends our continual appreciation to the dedicated group of tellers who weekly tabulate, record, and process the church's receipts (as well as those of the Samaritans).

A Financial Review Team consisting of Bonnie Sondrol, Dale Jones and John Merrill was appointed to review the financial policies and processing procedures of the church's financial business. The review was completed with recommendations for improvements provided.

The budget process for 2025 was begun.

The team also wishes to thank Amy, the church's financial secretary, for her timely, detailed and thorough work that enables us to do our work.

Report from the Church Audit and Review Committee on the Review of 2023 Church Financial Processes

Why, you might ask, would you be seeing a report of a Church Financial Review Committee in the 2024 Annual Report? The answer is to be found in The Good Shepherd United Church of Christ Financially Related Policies, May 22, 2012 Revision, Section III. Finances and Budget Presentation: Review of Financial Records, Audit. It states:

The financial records of the church shall be reviewed annually by at least a three-member ad hoc committee appointed by the Finance Team. If the ad hoc committee has a concern over the financial records, then an outside accountant's assistance will be sought. Starting in 2013, and at least every five years thereafter, the church will have an official audit conducted by an independent outside audit firm.

During October, November and December 2024, the Church Audit and Review Committee—comprised of John Merrill, Bonnie Sondrol, Dale Jones, and assisted by Amy Dillemuth—conducted a comprehensive financial review of the Good Shepherd Church financials for 2023. The review (not an audit) assessed compliance with the Church's Financially Related Policies (revised 05/22/12) and Generally Accepted Accounting Principles (GAAP). It was the first review since 2019.

We performed an examination of transactions on a test basis, reviewed internal control procedures and support for year end balances. Recommendations were made to the Admin Team and Finance Committee, and we are overall satisfied with the report. Copies of the Report can be obtained from the Finance Committee Chair, Richard Himbury.

Report of the Stewardship Team

This Annual Report of the Stewardship Team covers the 2023-2024 campaign as well as the 2024-2025 campaign *through February 2nd, 2025.*

The 2023-2024 campaign pledge target set by the Admin Team was \$375,000. 137 pledges for \$371,945 from near 200 members and friends of The Good Shepherd were received, plus an additional \$6,000 from the Estate and Patio Sales Group. Overall, we fell less than 1% short of our congregational pledging target.

The 2023-2024 Stewardship Team consisted of Pam Irvin, Lynda Himbury, Hathaway Cornelius (facilitator), and Pastor Randy Mayer, ex officio, plus Sandy Lindahl, consultant. The 2023-2024 stewardship theme incorporated the year's UCC theme, *Make a joyful noise to God*, from Psalm 100, in which the writer exhorts all to 'enter God's gates with thanksgiving and courts with praise'. An invitation to pledge, over the Senior Pastor's signature, was sent to over 230 members and friends in early January. 'Moment for Stewardship' presentations were made, by Barb Hunsinger, Rev. Mel Hurst, Francine Gilmore, and Sandy Dinnocenti. Celebration Sunday was January 21st.

The 2024-2025 Stewardship Team consists of Lynda Himbury, Pam Irvin, Pastor Randy Mayer, ex officio, Sandy Lindahl, consultant, and Hathaway Cornelius (facilitator). This year our campaign theme is *Imagine Together*. 'Imagine the impact we can have in our congregation and communities if Together we generously support them through our financial giving.' An invitation to pledge, over the Senior Pastor's signature, was sent to over 230 member and friend households in mid-January. Pledging opportunities included ePledging via the Church website. As of February 2nd, 93 pledges of support had been received for a total of \$260,791 toward our goal of \$382,000.

The Personnel Team introduced themselves to their staff buddy and continued to check in with him/her just to see how things were going. Some people chose to meet monthly; others were more casual. But each staff member knows the buddy has their back; they could help, simply chat or advise. Word is, this works well!

Next, the Personnel Team decided to honor the hard-working staff by hosting two luncheons, one in May and one in September. These get-togethers offered time for the whole staff to be together and have a chance to visit and get to know each other better. And they were fun.

We have seen staff members come and go this year, always bittersweet. Saying good-bye to Margaret Kofron was hard. She made quite an impression on the congregation and pitched in and offered her talents in numerous arenas. We said goodbye to Vocalist Susan Ahlstrom in the band and then welcomed Erica Corner in September. Our new leader of Faith Formation is Tatum Lawrence who is just in the process of on-boarding. Each departure and arrival requires paperwork, much of it falling to Amy.

We made an attempt to streamline the staff evaluation process and move it into October so that we missed the end-of-year crunch. An addition to the process is a self-evaluation that each staff member completes before the evaluation. At least two members of the Personnel Team attended evaluations with Randy.

Our focus is to welcome visitors to the Good Shepherd Church and include them in the many facets of the Church.

Our activities include:

- Kiosk: Judy recruits people to staff the Sunday Kiosk for first service and during the summer when there is
 one service. EWIT takes the responsibility to maintain the items in the Kiosk (i.e. visitor packets, pens,
 pencils and visitor registration forms).
- Ushers and Worship Leaders: Carrie finds for first service and during the summer. Janet Carter finds for second service.
- Circle of Friends: Flo Mayer and Mary Ferland organize potluck dinners which occur monthly from October through March. Sign-up sheets are posted on the Church Bulletin Board and announcements are made on Sunday mornings. You may host or be a guest.

Report of the Peace Patrol

The Peace Patrol of The Good Shepherd is tasked with developing best practices and security protocols to enhance the safety and comfort of our members and friends, including the adjacent Food Bank and Samaritans, during these unsettling times. The Peace Patrol was organized following identification by Homeland Security and the Southwest UCC of the Good Shepherd as a prime soft target. Members from both services currently serve.

In concert with our local law enforcement departments and our Good Shepherd Administration, multiple safety and security issues have been assessed and addressed. Our security systems are checked annually and new batteries installed as needed. De-escalation techniques trainings will continue to be offered.

Our request for a head usher was again presented to the Admin Team to designate a position of a head usher to be responsible for advising the cadre of ushers of the security and safety protocols developed by the Peace Patrol. And to encourage participation in de-escalation techniques.

At a minimum, we would ask that the ushers be given our Protocol Packet for them to read as they are the first line of welcome and hospitality. These are not to be limited to friendly greetings, seating etc., but should include recommended safety and security protocols such as securing doors, observing and assessing visitors, awareness of exit locations, et al.

The Peace Patrol recommends continuation of the presence of a security guard during Sunday services.

Report of the Mission, Service and Justice Team

The Mission, Service, and Justice Team (MSJ) is responsible to promote the 4 UCC special offerings throughout the year: One Great Hour of Sharing, Strengthen the Church, Neighbors in Need, and The Annual Christmas Fund. Different members of our team informed the congregation of the offerings through written announcements in the church newsletter and weekly bulletin, verbal announcements at both services, and our MSJ bulletin board. The congregation generously supported each of these collections to a total of \$8255.

Rick and Pam Irvin continue to provide delicious coffee for sale twice each month in support of Cafe' Justo.

The MSJ Team planned 3 special drives in 2024 to help our close-by neighbors, and those at Casa de la Misericordia in Nogales, Sonora.

Our first was a drive to provide new sheets and pillowcases for the 135 beds at La Casa. Much research was done on this project by Margie Nagle, and our plans were presented to the Admin Team. However, the Estate/Patio Sale Team very graciously stepped in and offered to finance this project. Sister Lika, the residents of La Casa, and MSJ were so very grateful to them.

Our second was a drive for art supplies for the Amado Youth Center. On a visit by Pam Irvin and Margaret Kofron to the center, it was discovered that their art room had almost no supplies. Once again, our generous congregation responded with leftover supplies from old projects, and newly purchased supplies for us to donate. Margaret Kofron also had the Sunday School kids bake and sell brownies to raise money for the project. Those at Amado Youth Center were very grateful.

Our third project was to help the newly reopened (they had been closed a few years) school at the San Xavier Mission on the nearby portion of the Tohono O'odham Nation Reservation. A request was made to the Estate/Patio Sale Team to consider the school as one of their charities for the year. They generously contributed \$1000 for school supplies and books. A short drive for coats/jackets for the children at the school was held in October. Again, the response was very generous and included 3 bags of hand-knit beanies. The principal and custodian of the school had huge smiles and many thanks when they were delivered.

Pam Irvin invited members of the team and the church family as a whole to participate in "Trunk or Treat" at the Amado Youth Center for Halloween. Those that went had a great time and look forward to participating again next year. We are looking for other ways to help the Center, and hope to have team members visit soon.

The Annual Mission Gift Fair was held toward the end of November. We again chose the Amado Youth Center, the Dee and Pres Johnson Probigua Scholarship Fund, and La Casa de la Misericordia as recipients. Susan Southwick and Pam Irvin co-chaired the event, and Sue Palfrey took care of publicity. Their hard work and the generosity of TGS family resulted in total donations of \$17,149 for our 3 charities.

Our team prepared well over 1000 food packs, sometimes with the help of the congregation, for the Samaritans to distribute to migrants.

Three long-time members of our team retired this past year, Mike and Margie Nagle, co-chairs, and Linda Sielken. The Nagles left us with an updated MSJ handbook, a great help!

Report of the Environmental Justice Projects Committee

The Environmental Justice Projects Committee has been researching, planning and educating the congregation about a proposed Climate Emergency Center at the Good Shepherd.

Background: United Church of Christ General Synod 32

Whereas, the urgency of the climate crisis is accelerating faster than anyone imagined:

Be it resolved, that The General Synod of the United Church of Christ calls upon the whole of the church, understanding the intersectionality of climate change and justice, to accept the moral responsibility that comes with living "at such a time as this" (Esther 4:14) by helping all communities be more prepared for extreme weather events and more resilient to the effects of the changing climate.

Climate change is exacerbating dangerous weather events. Southern Arizona is experiencing longer heat waves with higher temperatures. In 2024 Tucson recorded 112 days over 100 degrees; in 2023 18 days 110 degrees or higher. The probability of a heat emergency and simultaneous power outage is small but increasing. Among all types of climate disasters, heat waves annually cause the most loss to human life, with those over 64, and those with chronic medical conditions at highest risk.

Proposal

We propose a Climate Emergency Center to address the need to prepare our community for the dangerous situation of a heat wave combined with a power outage. The Climate Emergency Center will welcome up to 300 congregants and community members at a time for daytime respite and provide a safe air-conditioned space. Snacks and beverages will be provided. Separate space for pets will be allocated. A written manual for volunteer management and guidelines for guests of the center is nearing completion. Electrical power for the Center will be provided by a new, permanently installed back-up power generator.

The United Church Christ awarded The Good Shepherd a \$10,000 grant toward this project as an innovative climate resilience program that could be replicated by other churches and nonprofit entities.

Additional funds of \$60,000 will be raised by a Capital Campaign commencing after a congregational vote to proceed. Maintenance costs for the generator are estimated at \$500 per year and would be budgeted with other church facility maintenance items.

Motion to be presented at the Annual meeting

We, Connie Aglione, Michael Day, Kathy Babcock, and Dennis St John, members of the Environmental Justice Projects Committee move that:

The Climate Emergency Center project, as presented in the 2024 Annual Report, be approved to proceed, a Capital Campaign to fund it begin immediately and a generator be purchased when sufficient funds are raised.

Scouting America Annual Report

The Good Shepherd has sponsored three scout troops and a very active cub pack. All now operate under the re-imagined name of Scouting America to allow for the creation of girl troops. It's now clear that all genders, races, and backgrounds, regardless of a young person's physical ability are welcome to have the Scouting adventure that's waiting for them.

Troop 301 celebrated the advancement of 4 new Eagle scouts that joined the other 56 Eagles previously awarded over the troops' 20-year history. The troop chose to end the year with a farewell celebration in December that closed out the charter. The unit's scouts and leaders just aged out! The troop's equipment was absorbed by the remaining troops, but their award history will continue to be displayed in the Redman Room.

Girl Troop 247 celebrated 2 new Eagles and ended the year by adding two additional members. The Boy Troop of 367 also added 2 Eagles and expanded their membership by 8. Cub Pack 300 is co-ed and available to boys and girls from kindergarten through the fifth grade; they are introduced to games and activities that help perfect some of the early skills they will need to move up to join the troops. An open house in September resulted in 14 new Cubs. The very active units total about 75 youth. Monday nights are very active in the church: the congregation is always welcome to check out the fun!

Report from the Sahuarita Food Bank & Community Resource Center to The Good Shepherd Community

Sahuarita Food Bank continued its journey of growth and transformation during 2024. SFB-CRC is a one-stop hub serving southeastern Arizona. Nutritious food, safety-net navigation, health and learning programs along with workforce development have been provided to individuals and families seeking to move to self-sufficiency.

Thanks to the support of our donors, our volunteers, The Good Shepherd members and the community at large we were able to meet the challenges and embrace new opportunities.

Accomplishments in our focus on Nutrition:

- 1. Emergency Food was distributed to over 12,800 unique individuals during 2024.
- 2. Navigation services continue to be available for those who desire help.
- 3. Provided classes on diabetes, healthy cooking choices, holiday pie and cookie classes, and a pierogi class.
- 4. Food demonstrations with recipes
- 5. Piloted the *Food is Medicine: Prescription for Health* program which includes follow-up with medical personnel.
- 6. Catering for groups by our Culinary Chef.

Accomplishments in our focus on Learning and Workforce Development

- 1. Through our Saguaro Skills Center, licensed by the State of Arizona, SFB-CRC offers courses in welding and information technology with exams and national certifications leading to well-paid jobs in high-demand fields. Three students have graduated from the welding program and new classes have started to meet the need of 40+ on the waiting list.
- 2. The Community Resource Center continues its learning offerings of English, Spanish, Financial Wellbeing, computer basics, resume help and tax preparation at our site.
- 3. All these classes are offered in the rural communities of Summit and Arivaca through our outreach program, Project AZUL.

Accomplishments in our focus on Family Support

- 1. The Family Resource Center opened its doors, welcoming over 200 families into its nurturing environs. The FRC helps maximize children's brain development during the first five years of life. Over 220 activities have been offered to the parents and children.
- 2. The Good Shepherd has partnered with SFB-CRC as part of the church's mission by agreeing to rent space for this unique community program. One Mom described her time at the FRC: "I feel a part of something. Here I can learn and stop and rest and have time for both me and my children. I don't feel alone. It is a safe space."

SFB-CRC needs your help in the coming years as the government pulls back funding. Our budget for the coming year is \$1,470,840.00. We urge your continued support for SFB-CRC while we manage inflation and find new ways to meet the needs of our neighbors.

Report from the Green Valley-Sahuarita Samaritans

Green Valley/Sahuarita Samaritans (SAMs) continued to meet every other Monday at 8 a.m., both in person at the church and by zoom, in pretty much equal numbers, generally about 50-60 or more. However, our objectives, "to save lives and relieve suffering in the Arizona borderlands," took on new meaning in 2024 as meeting asylum seekers crossing at the wall 14- 21 miles from Sasabe became our major focus, rather than driving the back roads seeking to help migrants in need. Many of those seeking asylum were families, including young children, pregnant women and unaccompanied minors, whose numbers increased during the year. Countries represented ranged from Mexico and Central America to Haiti, Venezuela but arrived also from India, Pakistan, China, Russia, Albania, Ethiopia, Cameroon, and other North and Central African countries.

Early on it became clear we needed to cooperate with other humanitarian groups (Humane Borders, No More Deaths and Tucson Samaritans) to provide care throughout the day. Together we created camps to provide shelter, food and water. We began 4 a.m. trips to care for those who crossed overnight and were waiting for Border Patrol to pick them up. Doctors Without Borders was there also and contributed quality tents to replace personal tents and tarps. We made arrangements to rent porta potties. During the winter we provided warm drinks and hot food. The number of those helped daily varied: once in a while nobody, sometimes close to 100 people, generally upwards of 20, often 50-60.

Media, foreign and domestic, contacted us regularly. Their emphasis was on the stories of asylum seekers. When the Biden administration launched its anti-immigrant plan, the stories were directed more to the politics of humanitarian aid work, which we always redirected to the failures of multiple administrations to address a fair and equitable policy. Domestic coverage came from CNN, the New York Times and PBS with NewsHour coanchor Amna Nawaz and her team. She did a live broadcast from the border and some days later the NewsHour aired a longer piece. Local media also showed healthy interest.

For almost 20 years SAMs have been going Tuesday mornings to the Kino Border Shelter, to help prepare and serve meals, provide needed clothing and other services. This past year those deported from the US and asylum seekers have been men, women and families with children, and come from many of the same countries as were met at the border. Their numbers have been as many as 80 persons staying at the shelter to as few as 20, but the numbers coming for meals and other services represent 2-300 a day, many staying in other shelters in Nogales. In addition to meals, SAMs provided cookies for the children, hygiene kits for men and women, games for children along with toys, stuffed animals and dolls, the variety too many to enumerate, all donated by those wanting to comfort those at the shelter.

Water drops continued on a regular basis. In 2024 the team replaced 849 gallons of water at 37 caches, and drove approximately 4,300 miles over the year. Water replacements were down considerably across all routes compared to 2023. Only vandalism and theft were higher than 2023.

Volunteers with the Sonora Migrant Project welcomed migrants in Nogales, MX, those who had been deported and those waiting to enter the US legally. In Nogales, AZ, they welcomed those who had just entered legally. They offered food, children's treats, clothing and information about local migrant services. Toward the end of the year they were renamed Ambos Nogales.

Jan. 11-13, Common Ground on the Border/Border Issues Fair was held, with participants from across the US. There were trips to the border, informative speakers, music, participatory activities, and a viewing of the documentary, "Shura: The Road is Never Paved." The Javarita Coffeehouse featured Namoli Brennet. Attorney Margo Cowan and Border Journalist Melissa Del Bosque spoke Saturday morning. Pablo Peregrina provided music. Humanitarian groups and artists had tables on the patio.

Katrina Schumacher monitors activities at the DeConcini Federal Courthouse in Tucson, the busiest federal courthouse in the state, with 80% of the hearings connected to undocumented people coming into the state. Mass Plea and Sentencing hearings are held at 9:30 each weekday morning for 30-40 shackled defendants. Each has already been offered and accepted a plea deal not to be charged with a felony, but with a misdemeanor. They have already spent about two weeks in a private CoreCivic prison; the majority of all sentences was 30 days for a misdemeanor. These people have done little other than cross into the US and get caught. Hearings in 2024 accounted for 7,561 people. If you figure each was sentenced to 30 days, (the least possible), that means 226,830 days in a CoreCivic prison. If the bed rate is \$150 a night, the yearly cost comes to \$34,024,500. A cost to the US taxpayer.

Cash on hand at the end of 2024 was \$96,309, compared to \$91,418 at end of 2023. The American Waldensians donated a new 2024 4Runner for our work. Other major donations were \$10,000 from the Southwest Conference UCC and \$7,000 from Saguaro Christian Church in Tucson. Total donations and expenses were up substantially from 2023, the increased costs due to the increased number of asylum seekers helped at the Wall, increased donations a result of great favorable media attention.
